ORDER

Whereas many serious complaints have been received in this office against **Sh. Syed Saud Ziad, Sr. Chief Warden (Central)** bearing **Aadhar no. 220791244800** D.O.B. **31.07.1966** which shows that he has been involved in many undesirable activities and thereby tarnishing the image of Civil Defence Organisation.

Whereas, among the many complaints, a case of sexual harassment against **Sh. Syed Saud Ziad** was also received in this office which was referred to the Local Complaints Committee (LCC). Though the case was closed on the basis of the written apology submitted by **Syed Saud Ziad, Sr. Chief Warden (Central)**, it is clear from the written statements of the witnesses called before the committee that the conduct of the said **Syed Saud Ziad, Sr. Chief Warden (Central)** towards the female volunteers is highly undesirable and derogatory. The same was also vouched by a few other female CDVs who were heard in person by the SDM (HQ) on the directions of the District Magistrate (Central), though they were reluctant to give any written submissions fearing personal and social stigma.

From the above it is amply clear that the conduct of **sh. Syed Saud Ziad** is a clear violation under **6 (iii), 7 (v) and 8 (i)** of the **standing order No.1/2021** dated 15.09.2021. The renewal of tenure in respect of **Syed Saud Ziad, Sr. Chief Warden (Central)** has been on hold since 10.12.2021 on account of a case pending in the Hon'ble High court of Delhi. Now, in view of the above facts his application for renewal of tenure is also **Considered and Rejected** by the Competent Authority.

Now therefore, after careful consideration of the above facts and circumstances by the Competent Authority- Controller Civil Defence/District Magistrate (Central), it has been decided to discharge the services of **Sh. Syed Saud Ziad, Sr. Chief Warden (Central)** immediately under **Section 6(2) of the Civil Defence Act, 1968**.
