## **HEARING NOTICE**

Whereas, vide notification No. F.LAC/C/2020/092623813/440-452 dated 27/05/2024, the land measuring area 62 sq. mtr. **Property No. 8736-C & 8736-D, Rahat Ganj / Aram Ganj, Roshanara Road, Pul Bangash of Sub Division Kotwali in District Central** was notified for acquisition for MRTS Project Phase-VI starting from Janak Puri West – Mukundpur - R.K. Ashram Marg Corridor at Rahat Ganj / Aram Ganj, Roshanara Road, Pul Bangash New Delhi u/s 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 by the Collector, Land Acquisition (Central).

And whereas, ADM(Central) was appointed as Administrator, for Rehabilitation and Resettlement Scheme, under sub section (1) of section 43 of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

And whereas, as per the section 16(1) of the said Act, 2013, the administrator for Rehabilitation and Resettlement, upon publication of the preliminary notification under sub section (1) of section 11 by the Collector, shall conduct a survey and undertake a census of the affected families.

And whereas, vide letter No. F.LAC/C/2020/ 092623813/493-502 dated 27.06.2024, a joint survey was carried out on 12.07.2024.

And whereas, as per Section 16(2), the Administrator shall prepare a draft Rehabilitation and Resettlement Scheme which shall include particulars of the rehabilitation and resettlement entitlements of each land owner and landless whose livelihoods are primarily dependent on the lands being acquired and where resettlement of affected families is involved.

Now whereas the preparation of draft Rehabilitation and Resettlement Scheme is under process, therefore all the interested parties any family/individual/company/Govt. agency, being affected with the said Land acquisition, are hereby informed that they may submit their suggestions/comments in r/o draft R&R Scheme, if any, in the office of Land Acquisition Branch, Central District on/before 08.10.2024.

Further, interested person may also submit their suggestions/comments in r/o draft R&R Scheme during the hearing, scheduled in the conference Hall of District Central, 14 Darya Ganj New Delhi, on **08.10.2024** at **12.00 PM**.
