PUBLIC HEARING NOTICE

Sub: Public Hearing Notice u/s 16 (5) of RFCTLARR, ACT, 2013 for Land acquisition of land Measuring 62 Sq. mtr. at Property No. 8736-C & 8736-D Rahat Ganj/ Aram Ganj, Roshanara Road, Pul Bangash site for MRTS Project Phase -IV, starting from Janakpuri West to R.K. Ashram Corridor.

Whereas, vide notification No. F.LAC/C/2020/092623813/440-452 dated 27.05.2024, the land of Property No. 8736-C & 8736-D Rahat Ganj/ Aram Ganj, Roshanara Road, Pul Bangash in the Sub Division Kotwali of District Central were notified u/s 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 namely for MRTS Project Phase-IV Starting from Janak Puri West to R.K. Ashram corridor for the construction of overground exits of the Subzi mandi Ghanta Ghar underground metro station at Rahat Ganj/Aram Ganj, Roshanara Road, Pul Bangash published by the Collector in the part-IV of the NCT of Delhi Gazette dated 27.05.2024.

Whereas, the undersigned appointed as Administrator, for Rehabilitation & Resettlement Scheme, conducted a survey & census on 12.07.2024 u/s 16(1) of above-mentioned Act vide No. F.LAC/C/2020/092623813/493-502 dated 27.06.2024. Based on survey conducted on 12.07.2024, and SIA final report a draft Rehabilitation & Resettlement Scheme is prepared and notified in official gazette on 03.01.2025 and the same has also been published in two leading newspaper Hindustan Times (English) & Nav Bharat Times (Hindi) on 12.02.2025.

Accordingly, a public hearing u/s 16(5) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 would be conducted on 07.03.2025 at 3.00 PM at the affected area i.e., Property No. 8736-C & 8736-D Rahat Ganj/ Aram Ganj, Roshanara Road, Pul Bangash. Meeting Point is O/o Executive Engineer, Ghanta Ghar DMRC Land Pocket nearby Amba Cinema. Alternatively written submission may also be submitted in the office of the undersigned on any working days during office hours from the issue of this notice or till the day of public hearing i.e. till 07.03.2025.

If any families/individuals/companies/Govt. agencies are being affected with the aforesaid acquisition of land, may present in person or file their objections during the course of hearing on the said day to the undersigned.
