## PUBLIC NOTICE UNDER SECTION 21 OF THE RECTLARR ACT, 2013

Whereas, earlier, vide notification No. F.NO. LAC/C/2020/092623813/440-452 dated 27.05.2024. total 62 Sq. Mtrs. (0.0062 hectares) land at at Property No. 8736-C & 8736-D, Rahat Ganj/Aram Ganj, Roshanara Road, Pul Bangash situated in Revenue Estate of Village Dilli, Khasra No. 388 min., Sub-Division Civil Lines in District Central for public purpose, namely MRTS project Phase-IV starting from Janak Puri West to R.K.
