Public Notice under Section 21 of the RECTLARR Act, 2013

Whereas, earlier, vide notification No. F.NO. LAC/C/2020/09277228/377-389 dated 01.04.2024. total 170 Sq. Mtr. (0.017 hectares) land at Khasra No. 186, Jaipuria Mills, Kolhapur Road, Dilli Patti village of Sub Division Civil Lines in District Central for public purpose, namely for the MRTS project Phase-IV starting from Janak Puri West to R.K. Ashram Corridor at Jaipuria Mills Kolhapur Road for the construction of the overground exit of the Subzi Mandi / Ghanta Ghar Underground Metro Station. was notified under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013) and published by the Collector in the Part IV of the NCT of Delhi Gazette, dated 2nd April 2024. As such now, in accordance with section 21 of RFCTLARR Act 2013, notice is being given for intimating to all concerned that the Government intends to take possession of the land mentioned above which is required for "public purpose" and that claims to compensations and rehabilitation and resettlement in above land may be made by all interested by appearing personally or by agent or advocate stating the nature of their respective interests in the land and the amount and particulars of their claims to compensation for such interests, their claims to Rehabilitation and Resettlement along with their objections if any, before the Collector on 25th March 2025 at 11.30 AM in the Conference Hall of the office of District Magistrate (Central)
