MINUTES OF MEETING

Minutes of Meeting under the Chairmanship of the District Magistrate Central District, DDMA (Central) was held on 26.09.2025 at 03.00 PM at Conference Hall O/o The District Magistrate (Central) Regarding Road Safety in Central District.

The Gist of discuss as and dicisions taken is as following –

1. **Updation/Identification of Black and Dark Spots:-** It was decided during the meeting on 10.06.2025 that Traffic Police (Central/North) and road owning agencies such as PWD & MCD shall immediately provide updated list of identified black and dark spots but the list of dark/black spots is yet to be received from above agencies. In the meeting, it is again requested to provide the said list so that same may be forwarded to road owning agency for taking necessary action at the earliest.

It is reiterated that while identifying the black and dark spots criteria such as road condition, area vulnerable for women safety, passenger volume, peak hour's congestion, diversion, engineering faults leading to accidents etc. are to be considered. On the basis of findings corrective measure may also be proposed to find possible solutions.

[Action – DCP Traffic (Central Rage), DCP (Central/North), MCD, PWD]

2. **Deloyment of Ambulances in District Central:-** CATS department to assess the availability and approach time of ambulances in the district. CATS also to provide this statistical data and deployment plan. It was also decided that Zonal Officer CATS will deploy round the clock one ambulance near Govt. Hospital Burari. (24 x 7) to cover nearby areas; near Rajghat, Lal Quila, near Gauri Shanker Mandir, near Dispensary at Azad Market as per availability of Ambulance.

3. Delhi Police (Central and North) are again requested to submit report regarding fatal accidents as per provisions under Section 135-A Motor Vehicle Act to Road Safety Committee.

[Action –DCP (Central and North)]

4. **Enforcement of Traffic Regulations :-**The discussion has again been made on enforcement of traffic regulations. Traffic Police must take corrective/punitive action with regard to illegal parking & submit ATR in this regard. Further Report should also be submitted by Traffic Police regarding deployment of Traffic Police Personnel in accident prone/vulnerable areas & during peak hours.

To identify accident prone areas in the district so that such area can be facilitated with safety measures.

As per new directions regarding Bus Lanes, a bus lane discipline report to be submitted on or before next meeting of the committee.

Enforcement Officers of Transport Department to submit report regarding road encroachment on bus stretch lanes to concerned area SDMs.

[Action – DCP Traffic (Central Range) & MLO/DTO]

5. **To conduct campaign to spread awareness :-** It was also decided that awareness session to be organized regarding Road Safety in schools and related Educational Institutions in the 2nd week of every month. Students from two schools may be participated in one go for this purpose. The buses may be arranged by DM(Central) office with the help of TI Daryaganj. In this regard, Traffic Police and DDE (North/Central) to coordinate with one another for such awareness sessions. DDE Central & North are directed to submit an Action Taken Report (ATR) in this regard.

6. **Creation of wayside amenities :-** This matter was again discussed in this meeting. PWD, MCD will furnish list of public convenience available on roads. Further, they must also submit the details under consideration regarding construction of public conveniences. The road owning agencies (MCD, PWD) and Traffic Police shall regularly examine the areas where railings/footpaths/public convenience are required to be repaired, current status and requirement of blinkers/signage's/speed breakers near each schools & hospitals. The efforts must be made to cover all major schools & hospitals with appropriate signage's/blinker/ to ensure smooth access & stop antisocial approach. (Specially Majnu ka Tila to Wazirabad Flyover) and proper sign boards shall be installed at Jagatpur Flyover, and IP Flyover to ISBT, Kashmeri Gate. It was informed by Traffic Police that one major accident happened where in a bus collided with the safety barrier & fell down breaking it. To curtail speed of incoming traffic rumblers should be put on road also.

- a. Median reflector to be put on for better visibility
- b. Proper Cautionary signage's need to be put up
- c. Railing should be raised to minimize the probability of hazard.
- d. Location of footpath & railing required.

[Action – MCD and PWD]

7. All concerned SDMs to organize meetings with Traffic Police, MTAs, RWAs & NGOs regarding identification of designated Auto/Taxi Stands and also suggest inputs for smooth running of traffic in their respective area.

[Action – All SDMs, DDMA, Central- District]

8. **Signage Boards :-** Detailed discussion was held about the signage board and it is decided that signage board may be provided at following locations –

9. It was discussed during the meeting about closing of Rani Jhansi round about from long time, due to which traffic movement are affecting. The reasons for clousing of this round about may be find out and also explore the possibility for smooth movement of traffic at this locations.

[Action – DCP Traffic and PWD]

10. It is dicuss during meeting, to ensure proper lighting/cleaniness/security of subway located in between Metro Gate No. 3 & 4 at LNJP Metro Station.

[Action – Delhi Police and PWD]

All departments are requested to provide name and contact details of concerned officials/nodal officers regarding Road Safety, Chairman the DRSC, it shall be responsibility of EE, PWD, Central (Member Secretary) to ensure that the meeting ttake place as per guidelines.

Additional District Magistrate (Central) requested all departments to ensure the compliance as per the decision take in the meeting. The meeting ended with the thanks to chair.
